

JAMBOREE 2019 • SUBSIDY APPLICATION FORM

The Subsidy Fund was set up in 1994 so that club members in financial need could receive help paying for designated Club Sponsored events. Funds come from member donations, generously given for that specific purpose. Members who cannot afford the fees for Jamboree may apply for a 33%, 50% or 66% subsidy of the cost of Jamboree (based on need), if their annual pre-tax income is less than \$25,000 or if health problems, medical expenses, disability, unemployment, under-employment, etc., significantly impact their ability to pay. Subsidies are subject to available funds and other conditions.

Your completed subsidy application form must be postmarked by **June 30, 2019** or 2 weeks after Jamboree sells-out,

whichever is first. Act NOW if you want to apply!

You will be notified as soon as a decision on your subsidy application has been made.

- ◆ A cheque for the appropriate fee made out to "Out & Out".
